

## Georgia Department of Human Services (DHS) Coordinated Transportation

Transportation is also available in all 11 Middle Georgia counties for eligible clients of the Georgia Department of Human Services. Services are made available 24 hours per day, seven days per week with core hours of operation being from 6:00 a.m. through 6:00 p.m., Monday through Friday. Transportation is arranged for clients by DHS Human Service Providers using the DHS Transportation Consumer Registration and Trip Order Form. Trips are scheduled 48 hours in advance. ## Georgia Department of Community Health (DCH) Medicaid Non-Emergency Transportation

The Georgia Department of Community Health's Medicaid Non-Emergency Transportation program provides transportation for eligible Medicaid members who need access to medical care or services. This program only provides services to members when other transportation is not available and eligibility has been determined. Eligible Medicaid members must contact the transportation provider three days in advance of their appointment to schedule appropriate transportation. Appointments can be scheduled Monday through Friday from 7:00 a.m. to 6:00 p.m.
